Once again it is time for the annual **"Swanee"** Tournament.

This year marks the 16th year the "Swanee" has been held. It is hard to imagine how much time has gone since the tournament's inception. The first event was held September 1996, just a few months after I purchased College Billiards, Jay's "home court." He had recently passed away that previous June.

Over the years, the "Swanee" has experienced tremendous growth. The first year was a modest 64 players, the next three we limited the field to 96, but the continued demand required us to increase future fields to 128. One year the field actually reached 213, the largest tournament at that time in California history. We have since decided to limit the field to 192. The last few years we had a full field with 10-20 players on a wait list in case anyone needed or decided to drop out. My affiliation with several billiard establishments in San Diego and being Jay's "home court," made it the logical choice for the event when it started.

Last year the event was moved to Hard Times Billiards in Bellflower, CA where it will again be proudly held. The "Swanee" will continue to have a field size limit of 192 players. Doors open at 9 a.m. Saturday, the 4th with play beginning at 10 a.m. (see event flyer for additional information). It is necessary for every player who wishes to compete in this prestigious event to enter early. Please insure your spot in the "Swanee" as soon as possible. IMPORTANT ENTRY INFORMATION: All mailed or faxed entries must be received no later than January 31, 2012. After that date, CASH ONLY entries will be accepted in person only at Hard Times Billiards. No checks accepted after Jan. 21, 2012.
